

SCHEDULE TO LICENSE AGREEMENT: AUTHOR

All invoices pursuant to this Agreement must be received within 180 days of delivery and acceptance of services. Failure by Creator to send such invoice within the aforementioned time period shall be considered a waiver of right to payment for delivery of services for which no invoice was sent.
